SUMMER DAY CAMP NOTES

SWIMMING

Every Tuesday & Thursday

- Items needed: Each child **MUST** have a *swimsuit, towel, & swim shoes* (old tennis shoes, flip flops, or water shoes) AND AN EXTRA CHANGE OF CLOTHES.
- SWIMSUITS AND SWIM TRUNKS MUST BE WORN UNDERNEATH REGULAR CLOTHES when they arrive at school on swim days.
- If your child does not bring the above items or wear their swim clothes underneath their regular clothes, *they will NOT be allowed in the water* but may go on the trip to the pool.
- Children will not need a life vest or floaties.
- Please remind your child of the following rules:
 - a. They must follow the directions from their teachers & lifeguards
 - b. If they don't follow the directions they **WILL NOT SWIM** that day
 - c. They **MUST** keep their wrist band on at **ALL** times
 - d. FPCELC will not be responsible for goggles brought by children
 - e. Do not bring money-they will not be allowed to purchase drinks or snacks from vending machines
 - f. If they fight, they **DO NOT SWIM**
 - g. Please be respectful of others & their belongings, other schools and families will be there
